The total number of members is **11.6% up** on last year after being level in 2020, falling **7%** in 2019, falling **9%** in 2018 and falling **22%** in 2017.

Member numbers are -19% compared to 2016's high point (last year -27%).

Member numbers are +254% compared to 2012's low point of 68 (last year +228%).

- £1 trial memberships were successful conversation rate was 25% from 63 trials
- New access path, ramp and patio area installed
- New patio furniture installed
- Key-box clubhouse access for all adult members
- Tennis ball machine now available for all members to hire
- Inter-club Competitions Men's Team 1 survived in Division 1, Men's Team 2 finished 3rd in Division 3, Ladies Team finished 7th in Division 2, Mixed Doubles Team won the Plate competition
 Likely that there won't be a Division 1 men's team next year as those members have joined other clubs
- Pay-and-play had its first full year and proved popular without any issues
- Requirement for all members to pre-book courts has proved a useful way to deter non-member walk-ons
- Club Play new format introduced in response to pandemic safeguards continued with high numbers across two sessions during the peak season

Club Accounts

Sharon has done another great job as Treasurer and has produced accounts up to 30 September 2021. Summary from Sharon:

The club continues to be in a healthy financial position. We were closed from December 20 to March 21 which on top of the previous closure meant that most members had 6 months membership added onto their expiry dates. We were expecting cash flow to be low for the period April 21 to December 21 with no membership income coming in but with lots of new members it has been steady over the year and not the big drop I was expecting.

We did receive further grants from Flintshire CC totalling £10K for being closed in the first 3 months of this year.

We were able to spend on improving the Courts - new fence, path, new noticeboard, patio furniture. As well as a new ball machine, water boiler and hand dryer.

We did also spend £1000 on training juniors for their level 1 - £400 of it was using up a grant that we had received with the balance coming out of club funds

Overall, over the year we broke even with a small surplus of £73, so still retain the £31K in the bank.

The amount in Designated Funds has been increased to £24K, this money is set aside for resurfacing the courts (in 15-20 years' time), painting the courts and floodlighting.

Sharon is to speak to club member Mel Lewis to allow her to consider whether she is willing to take on the role.

Decision at last year's AGM was that we would reward those who pay in full by increasing the monthly membership amounts slightly, which would help guard against the occasional instances where people join and cancel after 2 or 3 monthly payments. **Discuss**: Monthly payments increase £2/month for Family, £1/month for Adult, £0.50 for Junior (saving around 15% by paying the full 12 months in one payment).
